The student Arunima Dev.M.D (2016-41-131) had wrongly written her Reg.Number on the answer book for the course Micr 2101– Agricultural Microbiology (2+1) & the student Anandhu Rajan (2015-41-113) for the course Stat 2102 – Introduction to computer applications {Re-Exam}(1+1) was indulged in malpractice & the college authorities did not allow the student to write the final theory exam as punishment. Accordingly, the results of these two students were withheld (vide ref. (3) cited). As per the ref.cited (4) above, the students through the Dean had requested to condone their mistakes, stating not to repeat it in future, and also requested to notify their withheld results. The Dean, College of Agriculture, Vellayani, had recommended the same by making proper remarks.
